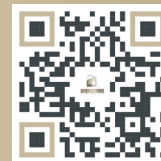

## EI TREATY TRADER VISA

If you own a Business outside USA, (in a US treaty Country), and your business trades (including product or service) primarily with USA, you may need to consider an E-Visa for USA for Treaty Traders.

### REQUIREMENTS & BENEFITS OF EI:

- Be a national of a country with which the United States maintains a treaty of commerce and navigation.
- The work you are conducting must be considered "trade".
- Carry on substantial trade. Substantial trade is defined as trade "sufficient to ensure a continuous flow" between the US and the treaty country.
- Carry on principal trade between the United States and the treaty country which qualified the treaty trader for E-1 classification.
- Investor must be vital to the success of the company.
- Trade can be for either Goods and / or Services.
