QUALIFYING FOR THE PROGRAM:

- Be at least 21 years old.50
- Demonstrate the legal origin of your investment capital.
- · Choose one of the two investment options outlined below:

Eligibility Criteria

- · Be at least 18 years old.
- Live in your current state or USCIS district for at least 3 months before applying.
- Hold a Green Card for an uninterrupted
 5 years before applying.
- Be physically present in the U.S. for at least 30 months out of the past 5 years.

INVESTMENT OPTIONS

1. CREATE A NEW COMMERCIAL ENTERPRISE (US\$1.8 MILLION MINIMUM):

- Invest in a new U.S. business venture.
- The minimum investment amount is reduced to US\$ 900,000 if the enterprise is located in a targeted rural area or an area with high unemployment.
- Generate at least 10 full-time jobs for qualified U.S. workers.
- Be actively involved in the day-to-day operations or policymaking of the enterprise.

2. INVEST IN A REGIONAL CENTER (US\$900,000 MINIMUM):

- Invest in a pre-approved business project by a U.S. Citizenship and Immigration Services (USCIS) designated Regional Center.
- Create at least 10 full-time U.S. jobs (indirect job creation may be allowed).

- Requirements for U.S. Citizenship through Naturalization
 While the USA EB-5 Investor Visa Program grants permanent residency,
