Attend a designated appointment in Portugal for submitting your application and biometric data in person (a valid Schengen visa may be required).

- **MINIMUM STAY:**

Fulfill the minimum stay requirements (14 days every two years after receiving residency cards).

Contribute €500,000 to support research activities in Portugal.

Invest €250,000 in artistic endeavors or national heritage restoration projects.

UNDERSTANDING THE FEES:

Application fees cover the main applicant and qualifying family members for the initial temporary residency application.

Additional fees may apply depending on your chosen investment option.
