Poland's high-income economy is the sixth largest in the European Union and historically one of the fastest growing. After economic liberalization in the 1990s, the country's gross domestic product (GDP) expanded at roughly 3% each year. The latest issue of The Economist, in fact, asserts that Poland has had its best 25 years in half a millennium, citing its relatively quick market - oriented recovery, decrease in public spending and insistence on keeping its native currency, the flexible zloty, while adopting to the euro. For these reasons and more, Poland was the only country in the EU - of which it's been a member since 2004 - to dodge the recession that struck Europe in the late 2000s.

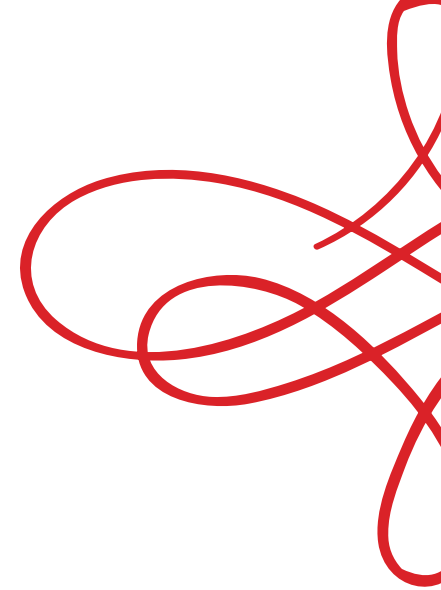

- Two partners can team up to form a single establishment (please consult Mahandru associates for the applicable price changes)
- Children under the age of 18 can be sponsored as dependent by the primary applicant after obtaining the residency permit
- The duration of the residency permit will be for 3 years which can be easily renewed with a moderate cost
- An assistance in obtaining a travel visa to log the application will be provided - if required
- As a resident of Poland, the investor and his/her family will be entitled for all the social benefits like free education and medical care.
- The residency card will allow the holder to travel and stay in any of the Schengen states for a period of 6 months.
- The investor will be entitled to apply for a permanent EU card and Polish citizenship after a period of five years.
- As a management team of the new established company, there won't be any physical staying requirements over the tenure of the residency
